The purpose of the line of credit is to provide seed funding for OHOF to develop its Home Team Advantage Program, a charitable initiative to provide affordable housing to low-income and needy individuals. Some of the funding from the line of credit was used by OHOF to repay a \$100,000 loan that OHOF had initially borrowed on a short-term basis (for a period of four months or less) from Offerdahl's Cafe Grill, Inc (the Cafe Grill), the proceeds of which had been used by OHOF for start-up costs for its Home Team Advantage charitable program. Although the Cafe Grill is a "disqualified person" with respect to the Foundation, the Foundation does not consider the use of its line of credit by OHOF to repay the funds initially borrowed by OHOF from the Cafe Grill to be an act of self-dealing, as the Foundation did not lend any funds to the Cafe Grill. Additionally, in light of this consideration, the parties involved have made the loan from the Cafe Grill non-interest-bearing. The net result of this arrangement is a loan by the Foundation to a 501(c)(3) public charity in support of its programs - which is the same net result that would have occurred had the Foundation made the original loan to the public charity. The recipient charity drew \$200,000 on this line of credit during 2016, which amount has been treated as a program-related investment and qualifying distribution. The Foundation monitors the use of the loaned funds and the repayment of the balance due by receiving regular reports on the use of the funds from the recipient organization, and by virtue of the fact that certain Board members of the Foundation also serve on the Board of the recipient organization.</p>
