The organization works with individuals to develop philanthropic plans to improve the quality of life in the Florida Keys. The organization also supports nonprofit organizations by helping them build endowment and operating reserve funds. Additionally, the organization works to strengthen the nonprofit sector and civic engagement in the Florida Keys through the Center for Nonprofit Excellence. During 2016, 4 new donor funds were established. In addition, 3 new legacy funds were established that will be funded in the future to make grants for specific needs within the community. During 2016 a total of 413 gifts were recorded and 227 grants were made. During 2016 the board of governors established the Florida Keys Future Fund, a Field of Interest Fund to expand its ability to make discretionary grants throughout the Florida Keys.

The Center for Nonprofit Excellence provides a wide range of resources and services that strengthen and support leadership and management of nonprofit organizations located in the Florida Keys. The Leadership Success Academy provides specific leadership and governance skills building to nonprofit board members. During 2016 there were 32 participants from 20 organizations. This marks the 10th consecutive year for the Leadership Success Academy. To recognize volunteer efforts, the organization for the last 17 years has conducted an Unsung Heroes / Volunteer of the Year luncheon to recognize the accomplishments of individuals serving nonprofit organizations. During 2016, there were 354 attendees representing 90 nonprofit organizations throughout Monroe County. In addition, the program offers a work space and conference room for nonprofit organizations without charge. An on-line resource library provides tools to research grant opportunities and nonprofit organizations can access subscriptions and research services from the CNPE conference room computer.
