Investigative Journalism Program. Cover those stories requiring more time and resources than what regular media have available
on a daily basis. The fact that most of those stories were picked up by traditional media speaks about the citizens' constant need for
analysis and well-researched investigative journalism. We are committed to dedicating our time and efforts to produce such stories
We published 43 research stories, 27 of them included interactive media like timelines, maps, graphs, infographics, videos, photo
galleries and podcasts. We addressed issues such as: corruption, environmental pollution, tax decrees, fiscal crisis, bondholders,
accountability, private business and processes related to the "PROMESA" Act and the Fiscal Control Board. Our webpage reached an
average of 46,500 unique visitors monthly, while our consolidated reach encompassing the impact of our publications in other media
sources was over 3 million readers. CPI received various awards from the Puerto Rico Journalists Association in categories related to
investigative journalism: O Alfonso, National Award in the category of investigative journalism, for his series about coal; E Martínez,
National Award in the category of special report, for his story about coffee industry; O Sosa, Honorable mention in the category of
written story or her story about Daddy Yankee, as part of the international Panama Papers series; L Trelles, National Award in the
category of radio special report, J Cintrón and C Minet, finalists in the research category, for series about bondholders in Puerto Rico

Journalism Training Institute / Educational Program: it helps journalists to develop investigative stories that may be of interest to the
community and provides educational and support tools as part of the editorial processes. This year our accomplishments were:
--We held six public events, with an estimated consolidated attendance of 450 people. One of the more important events was the
Forum Transparency in the context of the Fiscal Control Board
--We developed Chequéalo Puerto Rico, an electoral context project to fact-check what was stated by all gubernatorial candidates
in PR. We fact-checked 34 statements made by all five gubernatorial candidates during the electoral campaign. About 25 journalists
from different media participated in the fact-checks, in addition to receiving training in the method of verification of public discourse.
--We held three two-day environmental workshops, six virtual sessions and two days of fact-checking workshops for Chequéalo PR;
and an additional half-day seminar on the PROMESA Bill.

Transparency program: Protecting the citizens' right to information is one of the Center's pillars. 2016 accomplishments were:
--We participated in the report "Knowing more: A decade of access to information in the Americas" by the Alliance for the Freedom
of Expression and Information, which reviewed the case of Puerto Rico. We were also a founding institution of the Transparency
Network a group formed by media, nonprofits and government institutions to promote transparency in Puerto Rico
--The series of videos "Rights Are Yours Defend Them", produced for the CPI and Open Spaces by PR Association of Documentary
Filmmakers, won an Emmy Suncoast Award. An agreement was made with the Office of Government Ethics for the videos to be
validated as part of the training methods and credit hours offered by the agency to public employees
