Through the UCSF Foundation, One Mind Institute supports Assistant Professors in the Department of Psychiatry The latest Assistant Professor to benefit from One Mind Institute's funding is Devanand Manoli, MD, PhD Dr Manoli is developing genetic tools to understand the genes and neural circuits that control pair bonding and social attachment in prairie voles He established the techniques to generate, for the first time, voles with mutations in specific genes, and to label and manipulate neurons in the vole brain He plans to study the neural circuits that control social attachment, the changes that occur in these neurons during early and adolescent development, and how these circuits respond to early life stress This parallels Dev's clinical interest in the social attachment deficits seen in children and adolescents that are beginning to show signs of psychotic illness Dev plans to generate voles with mutations in genes implicated in autism and schizophrenia to understand the deficits in social attachment that are hallmarks of these disorders, and determine how these can be used to identify at risk populations earlier

The Staglin Music Festival Center for the Assessment and Prevention of Prodromal States (CAPPS) is a clinical research center at the Semel Institute for Neuroscience and Behavior at UCLA. CAPPS specializes in identifying and treating adolescents and young adults (between the ages of 12 and 30) at high risk for developing psychotic disorders, in the prodromal phase of schizophrenia. CAPPS aims to protect vulnerable youth in hopes that the full-blown illness does not develop.
