The next largest contributor was \$2,494 paid in credit card processing fees for various programs. \$2,000 paid for an accounting audit by Taylor and Roth, \$1,968 paid for insurance, \$947 in office supplies, \$826 for web site hosting and maintenance, \$605 in program advertising, and \$64 in banking fees.
