Energy Efficiency Programs:

Conducted door-to-door outreach signing residents up for free energy audits, recycling, trees and resources. We completed about 210 home energy audits in Denver and Commerce city. Low-cost and major energy upgrades, such as insulation or energy efficient appliances, were installed in many of these homes.

Urban Agriculture and Food Access Projects:

We managed our hydroponic greenhouse and over three acres of urban farms and gardens to produce local healthy food. The food was distributed to the community via pay-what-you-can farm stands, donations to social service agencies, and through the Denver Public Schools free-and-reduced price lunch program. Additionally, partnered with two other local non-profits to pilot a system to pickup extra produce from backyard gardeners for donation on a variety of projects, mentored by the older youth.

Green Team Youth Employment Program: GWD employed 64 youth who worked in urban gardens and on neighborhood improvement and civic engagement projects related to environmental issues as well as healthy eating and active living. Ages ranged from 13-22. The older youth (age 18-22) worked at the Rocky Mountain Arsenal National Wildlife Refuge and on other public lands. The youth (age 14-17) worked on community projects including urban farming and water quality. The youngest students (age 13-14) worked on a variety of projects mentored by the older youth.
