Rental income helps to cover cost of utilities for the building. This section also includes a short term loan in the amount of \$7500 issued from Nebraska Enterprise Fund (NeF). This is a state fund that small businesses can apply for funds to help with cash flow. There is not a repayment schedule. Organizations pay off their loan as funds are available to pay. Black Men United has had at least 2 of these loans in the past and has paid them both off before receiving any new funds. The last amount that is included in this category are transfer corrections. Black Men United maintains 2 accounts. One is for the funding received from the State of Nebraska and the other account covers all other business activity. Checks in the amount of \$5,450 were written on the account representing State of Nebraska funds when money should have come from the general account.
