Each coalition was asked to list the top five health needs. Coalitions participating in the discussions included: 1-Perinatal Coalition, 2-Faith Community Nurses, 3-Kid's Journey Coalition, 4-Safe Kids Coalition 5-Community Benefit Work Team. Resources from other organizations were reviewed to prevent duplication of services and enhance resources. Resources of other organizations were also reviewed to ensure identified needs were met. All of the entities and individuals provide compensation data independent of the others. Subsequent to the review, a recommendation regarding the CEO's compensation is reviewed and modified/approved by the Board of Directors of Houston Hospitals, Inc. A similar process is employed for the CFO and COO. The reviews are performed on an annual basis.
