THE PASSAGE OF THIS RAPE KIT REFORM LEGISLATION WAS A MAJOR VICTORY FOR SURVIVORS IN THE STATE. IN DECEMBER, GOVERNOR CUOMO (NEW YORK) SIGNED A COMPREHENSIVE RAPE KIT REFORM BILL. THE NEW LAW REQUIRES NEWLY COLLECTED KITS BE SENT TO A CRIME LAB FOR TESTING WITHIN 10 DAYS OF RECEIPT AND THE LAB TO ANALYZE THOSE KITS WITHIN 90 DAYS. LAW ENFORCEMENT AGENCIES ARE MANDATED TO SUBMIT ALL RAPE KITS CURRENTLY IN STORAGE TO A LAB WITHIN 180 DAYS OF ENACTMENT, THE LAB MUST COMPLETE TESTING WITHIN 120 DAYS OF RECEIPT, AND ALL UNTESTED RAPE KITS IN THE STATE MUST BE REPORTED ON QUARTERLY.

JOYFUL HEART HAS BEEN WORKING WITH THE POLICE FOUNDATION AND THE NATIONAL CENTER FOR VICTIMS OF CRIME ON A RESEARCH PROJECT EXAMINING THE MANDATORY RAPE KIT TESTING LAW IN TEXAS (SB1636) AND ANOTHER LAW (SB1191) INTENDED TO INCREASE ACCESS TO SEXUAL ASSAULT FORENSIC EXAMS. THE PROJECT'S OBJECTIVE IS TO DETERMINE WHETHER THE NEW LAWS ARE INCREASING THE RATES OF REPORTING AND WHETHER THE RATES OF ARRESTS, PROSECUTIONS, AND CONVICTIONS HAVE INCREASED. THROUGH OUR ROLE IN THE TRAINING AND TECHNICAL ASSISTANCE SAKI GROUP, THE POLICY TEAM WILL SUPPORT THE NEW GRANTEES INCLUDING LAW ENFORCEMENT AGENCIES IN HAWAI'I, NEW MEXICO, ALASKA, AND MONTANA.

WITH THESE KITS INCLUDED, WE HAVE DISCOVERED MORE THAN 39,000 UNTESTED RAPE KITS IN 41 JURISDICTIONS.
