Of those 13,900 provided sessions, approximately 16% are provided for little or no fee. The demand for the services offered through CFCC & Associates, Inc. continues to increase and we are now providing services through seven outpatient treatment centers and four equine assisted treatment locations. We are looking forward to our outpatient and equine treatment centers expanding out farther into the region.
