A GRANT WAS PROVIDED TO FUND A PROGRAM TO TRAIN ALL CHIEF RESIDENTS AT THE OSU MEDICAL CENTER IN CRUCIAL CONVERSATIONS, A PROGRAM DEMONSTRATED TO IMPROVE PATIENT SAFETY. THE FOUNDATION ALSO PARTNERS WITH THE POST GRADUATE TRAINING PROGRAMS AT OSU MEDICAL CENTER TO PRESENT MONTHLY LECTURES ON THE BUSINESS OF MEDICINE WHICH REACH NEARLY 100 MEDICAL STUDENTS AND YOUNG PHYSICIANS MONTHLY. WITH OUR GRANT OF \$5,000 THEY WILL PROVIDE ASSISTIVE DEVICES TO SENIOR ADULTS WHICH WILL HELP MAINTAIN INDEPENDENCE. HOPE, AN AGENCY WHICH PROVIDES COUNSELING, TESTING, AND EDUCATION ON HIV AND STI'S WAS ABLE TO PURCHASE SUPPLIES FOR TESTING IN THEIR SPECIALLY EQUIPPED VAN WHICH TRAVELS TO RURAL LOCATIONS WITH THE \$7,500 FUNDING PROVIDED BY THE FOUNDATION. OUR COMMITMENT TO QUALITY END OF LIFE CARE WAS DEMONSTRATED WITH A GRANT TO HOSPICE OF GREEN COUNTRY FOR THEIR COURTESY CARE PROGRAM.
