Our agency provided services to victims of domestic violence, sexual assault and child abuse. Our 30-day crisis shelter served 219 victims; our hotline served 477 crisis calls; contacts made with victims in 2016 include 641 through the Counseling program, 753 through shelter advocate program, 412 including adult sexual assault exams through sexual assault advocate programs and 375 through child advocate program. Contacts made include case management, safety planning, transport, treatment plans, etc.
