The STAR Project provides reentry services to individuals exiting incarceration within Washington. During 2016, STAR served over 134 ex-offenders and their families through best practices in the field of offender re-entry, utilizing the following programs: pre-release transition services, comprehensive case management, housing support, and employment support. Ex-offenders with felony convictions are considered to be at a higher risk of chronic homelessness as outlined by the Department of Housing and Urban Development (HUD). As such, The STAR Project Housing Coordinator works with landlords to secure adequate, appropriate housing for clients. Further, as the median income for STAR clients is \$0 per month at the time of intake, STAR administrative staff actively pursues grant and donation funding for housing units. Rental/shelter assistance is usually provided to qualifying clients for up to 90 days. To aid ex-offenders in building life skills which will aid them both in transition and remaining out of the criminal justice system, all clients participate in personal development programs. These include weekly Moral Reconation Therapy (MRT) courses, a best-practices cognitive behavioral program facilitated by the STAR Case Manager, monthly support groups centered around a meal, and being paired with a mentor. Clients also receive employment or education support through the STAR Employment Specialist. In 2015, 50% of STAR clients were fully self-supporting within 90 days of enrollment for services. This comprehensive, wrap-around service model has resulted in a recidivism rate of just less than 9.5% during the critical 3-year reentry period, in contrast to the state average of 32.2%.

Part I, Line 2	The STAR Project maintains accurate data on client demographics, assistance provided, accomplishments achieved, and when needed, why services were terminated. This data is reported to funders, including Walla Walla County, who distribute homeless prevention dollars from state and county agencies. Data is secured electronically through the federal Homeless Management Information Services (HMIS) database and kept for no less than seven years following service provision. Eligibility for STAR services require that an individual be released from incarceration within a year of service and that they be required to remain in Walla Walla County as per court order or that they have established support services within the county. Additional requirements must be met for housing support as outlined by funding sources. As STAR clients all fit into the category of chronically homeless and on average have median incomes of 3% of county median, these criteria are usually easily met.
