The By-laws ("By-laws") of G. L. Brennan Foundation, Inc., an Oklahoma not for profit corporation (the "Company"), were adopted on December 20, 1957. The By-laws authorize and approve their alteration or amendment by a majority vote of all of the members of the Company. The members, pursuant to a unanimous vote at their Annual Meeting on December 7, 2015, have authorized and approved the amendment to the By-laws, upon and subject to the terms and conditions of this Amendment to By-laws (this "Amendment"):

1. Article III – Trustees.

Section 2 to Article III is amended to read in part as follows:

**"2. The number of trustees of the corporation shall be four. ... "**

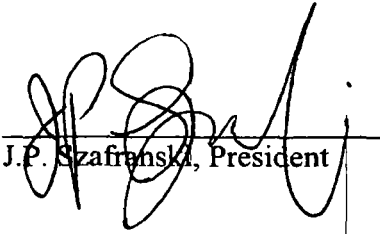
2. No Other Amendments.
