EMI is an organization of Christian professionals from many nationalities who serve as a technical resource for development, construction and disaster relief mission work around the world. In 2016, EMI worked on 72 projects in 26 countries, sending out teams that totaled 183 volunteers and 51 interns. These projects represent design work that will enable the construction of hospitals, schools, orphanages, water pipelines, ministry centers, youth camps, churches and places to live for some of the poorest people in the hardest to reach corners of the world. From hospital projects in Haiti and Kenya, to a design/build electrical system installation in Tanzania, to a church building in the Philippines - EMI teams provided strategic planning, design, and construction assistance to many clients in a variety of critical times and places over the course of the year.
