In 2016, Durango Education Foundation continued to concentrate on giving financial support to Durango School District 9-R (9-R) classrooms and to community organizations which serve 9-R students. Every school in the district received funding from DEF efforts. DEF funded grants to teachers and community organizations to support a range of academic programs, materials and technology needs throughout the school district. Grants funded such needs as: interactive technology devices, independent reading libraries, research references, robotics kits, and more. DEF grants affected the education of some 80% of the students in the district. DEF administered scholarships and academic awards, provided grants for performing and visual arts education, and assisted various student academic competition teams with travel expenses. As fiscal agent, DEF assisted in fundraising for the Durango After Prom Association activities and the renovation of the Durango High School stadium. And finally, DEF also advocated for passage of a school funding mill levy (Ballot Measure 3A) with active engagement in creating messaging materials and hosting a pro/con education forum on the measure.
