


Other

The Foundation received a one-time special contribution of \$32.4m as part of Bank of America's satisfaction of its Consumer Relief obligations, set forth in Annex 2 of the settlement. Per Annex 2, all state-based IOLTA organizations received a portion of the special contribution pro rata based on each state's poverty population. The Foundation's board of directors granted the first of two 2-year grants for foreclosure prevention legal assistance and community redevelopment legal assistance.
