WHEAT's education programs provide awareness, ongoing training and tools for action in the fight against hunger including workshops, presentations, skill building. Programs include the Norma Johansen Hunger Library providing resources of all kinds, free of charge, for book discussions, youth motivation, teaching and more. WHEAT's Training and Mentoring program provides management level training including on-the-job training, workshops, personal and professional development seminars for people who are underemployed or unemployed. This job training gives the participants marketable skill to become gainfully employed. Job Training and Mentoring includes WHEAT's Youth Leadership programs, providing mentors to youth at risk, while they receive job experience and attend workshops on career development and future educational opportunities. Recipients are low income Arizona residents. WHEAT graduated 412 individuals from Management Training, 175 high school youth in the Youth Leadership Program; provided SNAP Outreach at 58 locations, statewide, and presented 91 lectures, workshops and key notes in 2016.

WHEAT's Clothes Silo and Work Wear for Men projects provide free, professional clothing to men and women in need who are entering or re-entering the workforce. Serving 7,239 women and 619 men in 2016, the program provides clothing, as well as personal shoppers who give the clients special attention to find just the right outfit for the job interview or first day on the job. The programs, started in 1985, also provide special networking opportunities and additional workshops for th clients throughout the year. The clothing is also available for much-reduced, affordable prices to the public to support the expenses associated with the programs as well as to provide a great source of professional wear for those who have little extra to spend on attire. Recipients of free services are low income Arizona residents; customers come from all walks of life, including those who love to support the program and love a great deal on great clothing, too.

The Hand to Hand Project, a fair trade initiative, is another of WHEAT's major empowerment programs. It includes the Fair Trade Store, making fairly traded gifts and goods available to the public through purchase while helping the artisans in 43 countries become self-sustaining, able to feed, clothe, shelter and educate themselves and their families. Fair trade is a very successful and positive way to fight hunger and poverty, worldwide. WHEAT empowered 60 artisans and their families to self-sufficiency in 2016.
