Part I, Line 2	The San Antonio AIDS Foundation has a Quality Management Program that focuses on monitoring and analyzing data to ensure the quality of all core medical services for persons living with HIV and AIDS. We analyze data that is collected via ARIES, the state database utilized by organizations who received funding through the Health Resources and Services Administration (HRSA) for Ryan White HIV/AIDS Treatment Modernization Act of 2006 programs (formerly the Ryan White Comprehensive AIDS Resources Emergency [CARE] Act). Our Quality Management program focuses on evidence-based care outcomes, quality assurance and quality improvement. We also utilize quality scorecards for performance review of metrics established by the City of San Antonio for housing programs funded via Housing and Urban Development (HUD). Data for all funded services undergoes a regular review by various methods: client surveys, performance outcome reviews based on standards of care set by various grantors, and focus groups. We undergo independent audits by each funder (private Foundations, city, county, and state agencies), in addition to our own internal quality management reviews. As a United Way partner agency we have an accountability review annually of our medical care program and prevention education program, and a site visit by a group of community volunteers who look at performance based on community need.
