County Service Officer. Funds are received from the State on a July to June fiscal year. This can
create a situation where more funds are expended during a Post fiscal year than what were received
during the same period.

Veterans Assistance consist of three components. 1)The All Veterans Honor Guard performed about
200 military honors for deceased veterans. On occasion families of the deceased will donate funds

and their families. In addition to the Grant funds identified above, the Post has its own fund to
assist needy veterans and their families. This fund it is maintained by the Post Service Officer.
The fund is used to provide assistance beyond what is authorized under the Grant and to provide
assistance in the period between when Grant funds are available. 30 Donations to Veterans
organizations Honor Flight, Wounded Warrior, Hbot, Distribution Center
