These expenses also include improvements for many other parks as only the largest projects are listed in Part III. APF funds Movies in the Park and Fitness in the Park throughout the City. And finally grants and other assistance for parks are included at \$614,290 and detailed in Schedule I, Part II.

The grant report must include "before and after" photographs, project financials, and a written narrative. APF staff conduct a site visit once work is completed. In addition, the Chief Mission Officer reviews grant project expenditures at the end of each month to ensure appropriate spending. Austin Park Foundation awarded grants to various organizations on behalf of parks in the Austin area. Funds were paid directly by Austin Parks Foundation to the vendors performing the work on the parks, therefore these grants are not detailed on this schedule (Schedule I).
