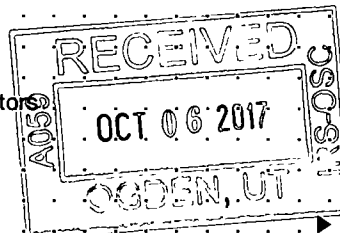

provided 6th grade. Candidatees are screened and recommended by a committee of Honduran agents (Jaun Pablo Aguilera) then

finally approved by a US committee of sponsors. Students are approved each semester only if they have passing grades. Also,

some economic assistance is provided for a few adults for short term vocational training.

Line 16 - other expenses - international banking transfer fees.

Austin Helps Honduras has never received support from a government entity.
