CPAW, which was created in cooperation with Wild fire Planning International and is funded through the U S Forest Service and private foundations, works with communities across the country to provide technical assistance such as land use planning, forestry expertise, and risk assessments. Headwaters Economics worked with nine other wildfire experts to publish a paper with seven key science insights important to inform future policy discussions and development options by decision makers such as Congress or federal and state agencies. The paper highlights key insights that can help contain costs and promote resilient communities facing more wildfire in the future. The manuscript was hosted initially by Headwaters Economics on its website, as well as by framing.gov. Headwaters Economics released a report showing how five urban areas in the West are using innovative land use planning tools to adapt to the increasing risk from wildfires. Each case study demonstrates a unique approach toward wildfire mitigation, and together they represent a suite of land use planning strategies that can be selectively applied elsewhere. In addition, Headwaters Economics analyzed the role of private insurance and whether rates and policies alone determine whether or not a landowner decides to build a new home on wildfire-prone land. The report found that the most likely way that insurance companies will play a role in reducing wildfire risk is by developing financial rewards, such as lower rates, that are tied to fire-safe practices such as the use of flame-retardant building materials, creation of defensible space, and reduction of flammable fuels near homes. As part of its effort to help communities threatened by wildfire, Headwaters Economics released an interactive map tool and sortable data table that identified every community across the United States threatened by wildfire from 2000-2014. The map and data are sortable by the different sizes of wildfires and distances from nearby communities and may be useful in identifying frequently impacted areas for those working to help communities become fire-adapted. Headwaters Economics released a new easy-to-use, free tool Populations at Risk (PAR) that quickly creates reports in Excel or PDF format about populations more likely to experience adverse social, health, or economic outcomes. From census tracts to states, users can compare or aggregate geographies.
