IF THE ENTITY IS GRANTED FUNDING THE FOLLOWING YEAR, THEY THEN OFFICIALLY JOIN THE UNITED WAY AS A MEMBER AGENCY. THE UNITED WAY OF LAMAR COUNTY HAS 21 MEMBER AGENCIES AND SIX ADDITIONAL GRANTS WERE MADE OUTSIDE OF THE ALLOCATION CYCLE FOR 2016. MEMBER AGENCIES ARE REQUIRED TO UPDATE UNITED WAY OF LAMAR COUNTY ON ANY CHANGES IN PROGRAMING AND FUNDING. THE B&A INTERVIEWS ALSO HELP IN GETTING RELEVANT FEEDBACK ON CHANGES IN PROJECTS. ADDITIONALLY, MANY OF THE UNITED WAY BOARD MEMBERS ALSO SERVE AS BOARD MEMBERS FOR OUR AGENCIES GIVING US ADDITIONAL FEEDBACK OF POTENTIAL CHANGES.
