The credit union provides multiple types of deposit products and services to its members, including savings, checking, money market and certificates of deposit. Excess Deposits not used for Lending purposes are used to purchase Investments in order to generate Investment Interest Income and related Investment Gains and/or Losses on Investment Sales
