To strengthen institutional capacity ensuring organizational development and growth Monthly management meetings were continuously held throughout 2016. The US-based Executive Director participated via Skype. This gave management the ability to maintain a deep oversight of the organization. COU was recognized by longtime partner school St. Cyprian High School and was awarded a Certificate of Appreciation for the services rendered for vulnerable children. St. Cyprian is one of the top secondary schools in Uganda and this was a remarkable honor. COU's alumni association was successfully reinstated in 2016. The group met monthly and began strategizing activities they could implement to mentor the younger students and give back to COU. COU's management prepared and disseminated monthly, quarterly, and annual reports for the US Board of Directors. These reports were critical in evaluating the performance of the current strategic plan, monitor student's welfare and scholastic performances as well as recognize their many successes. A team of consultants from Cable Media were retained to train and equip staff with basic skills in using the Monitoring and Evaluation tools and templates. The consultants provided them with a temporary working database that greatly enhanced their ability to track their progress against performance goals. Power-inverters for both the Kampala and Rakai offices were acquired in 2016 - enabling administrative offices to work through consistent power blackouts and thus increasing their productivity.

To improve access to basic health care services, counseling and psychosocial support programs In partnership with ALIVE Medical Services (AMS), general medical check-ups were performed for 47 students from the Kampala/ Mukono operational areas This exercise was ongoing by end of year and would continue in 2017 The impact on the children was two-fold - they remain strong and healthy and thus able to concentrate on their studies and perform at their best Student vaccinations - as per our current strategic plan - are up to date and overseen by health care providers This enables COU management to have better knowledge of our students' health status and intervene when necessary COU continued their support of partner schools' health clinics - mostly at Kamuli Primary School where the school clinic was facilitated with beddings, medical supplies among other items Ongoing support of other partner schools will continue in 2017 with donations of basic medical supplies to their respective health clinics Health education seminars continued in 2016 including a health sensitization talk with the children before conducting their medical examinations Additionally, a robust health talk was given to the primary students with the goal of giving the students useful tips on how to be healthy A new partnership was forged between COU and the Medical Dental Missioners Africa (MDMA) and they committed to free medical and dental services for the Rakai operational area in May 2017 COU also continued their commitment to ensuring that the most vulnerable children (who would otherwise not have access to a doctor) received medical treatment A total of 11 children (COU is committed to a minimum of 10) were supported with necessary medical care Girls' personal hygiene products were provided throughout the 2016 academic year - which continued to give the teen age girls self-confidence and increase the number of days the girls remained in school each month Menstruation does not interrupt the education of COU's older students

This enabled additional support for COU supported OVC at the sub county level and increased visibility of the organization through increased shareholder engagements. COU actively participated in Annual General Meetings at the partner schools and COU continued to forge strong partnerships with the school and their head teachers. This was another key opportunity that increased organizational visibility. COU partnered with CEDA and participated in the International Women's Day charity walk. COU was honored to give back to the community and maintain strong social responsibility. This gave the opportunity to encourage students to participate in events of this nature that are focused on our core values: child equality and child protection. COU established partnerships with the community and with student's parents/guardians to promote the value of education. Having the strong support of the guardians dramatically increases the academic performance of the children and gives the guardians a better appreciation for the value of education. COU identified 20 COU guardians to benefit from income generating activities (IGAs) and trained them according to their IGA. Guardians were equipped with financial management knowledge that encouraged them to save money and also enabled them to join the Village Savings and Loan Associations (VSLAs). This is a vital component of the family empowerment program - giving our guardians long-term, sustainable skills that will help become self-supporting and better able to care for themselves and their family. Four Village Savings and Loan Associations (VSLAs) were set up during 2016 - 3 in the Kampala / Mukono area and one in Rakai. All groups were well managed. Members shared their savings and profits at the end of the year. In Kampala/ Mukono - they totaled Ugx 11,212,000 and in Rakai they totaled Ugx 446,000. Members used their money to start up personal IGAs or add capital to their already existing small businesses.
