The Project Green Challenge (PGC) Program is a global call to action for college and high school students to transition from conventional to conscious living. PGC engages youth by uniting them in a commitment to cultivate a healthy and just planet and is comprised of 30 sustainability-themed challenges in 30 days throughout the month of October. During 2016 PGC engaged 4,018 students from 536 schools in 50 states and 37 countries. 16 finalists from the global pool of participants were flown to San Francisco in late November to attend a four-day eco summit, where they had the opportunity to interact with esteemed environmental leaders, present their experiences from the 30-day Challenge, and work together to create innovative platforms for social action. Their ideas were further developed by the students and mentors and implemented by Turning Green, its partners, and youth nationwide for the coming year.

## **Form 990, Part III, Line 4b:**

The Conscious Kitchen program partners with schools, guiding them to implement food programs based on five foundational principles: fresh, local, organic, seasonal and non-GMO (FLOSN). The Conscious Kitchen is a pilot program at Bayside Martin Luther King Jr. Academy, in partnership with Executive Chef Justin Everett of Cavallo Point Lodge, as well as Whole Foods Market, Good Earth Natural Foods and the school district. In just two short years, The Conscious Kitchen has transformed school culture in the dining hall and beyond. Teachers have reported increased leadership qualities exhibited by students, improved academic performance, a 67% decrease in disciplinary cases, and an increase in attendance. Teachers have also observed students treating one another with respect, improved manners and open communication. Through their participation in menu development, food preparation, service, and zero-waste cleanup, students now have a sense of pride and ownership in their school food. For the first time, they are coming together with staff to share meals in an inclusive dining experience that fosters conversation, joy, and trust.

The Conscious College Road Tour Program visited 16 college campuses throughout the country, from Ohio State to Temple University to UCLA, to offer tangible ways for students to live more consciously (education around safer and healthier practices and products) and be the change (advocacy campaigns and TG programs) and support specific, relevant, actionable sustainability projects with stakeholders on each campus. Events included The Conscious Information Station, and Town Hall Meetings, an evening dinner gathering for students, faculty, and school leaders focusing attention on a student-led sustainability project to be developed on campus.
