Mental Health Assessments: EPACT provided 111 substance abuse, domestic violence and parental fitness assessments to 81 families resulting in the identification of additional resources and services needed to combat substance abuse, child abuse and family violence; and identify the skills needed to increase parental protective capacities. 3. Parent Aide Services: A total of 88 families received parent-aide services that included supervised visitations; life skills and parenting education training that resulted in enhanced protective capacities for parents, reunification and safer home environments.
