The National Fencing Foundation SYC - Capitol Clash is the largest youth fencing tournament ever, comprised of events for athletes ages 8 to 16. Competition is divided by age category and weapon, with athletes testing their skills in all three Olympic weapons - foil, epee and saber. Youth compete for medals, the coveted Jefferson Cups and national youth ranking points for qualification to the US Summer National Championships. The event is part of the Super Youth Circuit (SYC) series, sanctioned by the US Fencing Association (USFA) under the authority of the US Olympic Committee (USOC). Over 1000 youth fencers, including future Olympic hopefuls, from all corners of the US and Canada compete at the Capitol Clash tournament in National Harbor, MD.
