Texas Health Harris Methodist Hospital Fort Worth (THFW) is a 640-staffed bed, Magnet-designated regional referral hospital that has served the residents of Tarrant County since 1930. The hospital's services include cardiovascular services, neuroscience services, high-risk and routine obstetrics and gynecology, orthopedics and sports medicine, neonatal intensive care, kidney transplant services, and trauma/emergency medicine. THFW is also home to the 100-bed Texas Health Harris Methodist Heart Center. The hospital was designated a Level II Trauma Center by the Texas Department of Health, named as a Cycle III Chest Pain Center by the Society of Chest Pain Centers for Percutaneous Coronary Intervention and designated an Acute Heart Failure Center. THFW is a designated Comprehensive Bariatric Surgery Program hospital and its Brain Injury Transitional Services program has been accredited by the Commission on Accreditation of Rehabilitation Facilities as an Outpatient Brain Injury Specialty Program. It was also certified as a Primary Stroke Center, a Spine Program and a Palliative Care Program by The Joint Commission. More than 4,000 employees work at this hospital and nearly 1,000 physicians are practicing on its medical staff. THFW provides quality medical healthcare regardless of race, creed, sex, national origin, handicap, age, or ability to pay. The hospital provides care to persons covered by governmental programs including Medicare and Medicaid for reimbursement that does not always cover the cost of providing the care. Recognizing its mission to the community, services are provided to both financially indigent and medically indigent patients. Community benefit is provided through many programs to the community. These services are essential to provide complete healthcare to the communities served. THFW provides the resources and support to nurses participating in the Faith Community Nursing (FCN) program. With special attention to congregations in underserved areas, the FCN program has covenants with over 50 congregations providing health screenings, health education and support for families of their congregations. THFW is part of a Child Automobile Safety Initiative whose mission strives to educate and raise community awareness about child safety. During the year, THFW had 196,181 patient days, 36,108 discharges, 201,583 outpatient encounters, 156,666 emergency room visits and 3,541 births.

Part II - Community Building The organization participates in community building activities that aim to address the socio-economic factors that influence the overall health of individuals in the communities served. Our volunteerism, collaborations and partnerships with various aid organizations and various area coalitions aid in addressing the socio-economic factors that are the backbone for many underlying health concerns. THR's annual audit is conducted on a system-wide basis with a single consolidated audit report issued for THR and its affiliates. The audited financial statements of THR, which includes the activity of the organization, contain a footnote regarding Accounts Receivable and Allowance for Doubtful Accounts that reads as follows: Patient accounts receivable are reported net of estimated allowances for doubtful accounts and contractual adjustments in the balance sheets. The allowance and resulting provision for bad debts is based upon a combination of the aging of receivables and management's assessment of historical and expected net collection considering business and economic conditions, trends in health care coverage and other collection indicators for each of its major payor sources of revenue. Management assesses the adequacy of the allowance for doubtful accounts based upon historical write-off experience and payment trends by payor category. Patient accounts are also monitored and, if necessary, past due accounts are placed with collection agencies in accordance with guidelines established by management. For receivables associated with services provided to patients who have third-party coverage, the System analyzes contractually due amounts and provides an allowance for doubtful accounts and a provision for bad debts, if necessary (for example, for expected uncollectible deductibles and copayments, or for payors who are known to be having financial difficulties that make the realization of amounts due unlikely). For receivables associated with self-pay patients (which includes both patients without insurance and patients with deductible and copayment balances due for which third-party coverage exists for part of the bill), the System records a significant provision for bad debts in the period of service on the basis of its past experience, which indicates that many patients are unable or unwilling to pay the portion of their bill for which they are financially responsible. The difference between the billed rates and the amounts actually collected after all reasonable collection efforts have been exhausted is charged off against the allowance for doubtful accounts. Texas Health Fort Worth	<p>for doubtful accounts for self-pay patients (including allowances for charity care) increased from 96.1% of self-pay accounts receivable at December 31, 2015 to 97.7% of self-pay accounts receivable at December 31, 2016. In addition, the Systems self-pay write-offs for bad debts increased from approximately \$250,000,000 for fiscal year 2015 to approximately \$306,000,000 for fiscal year 2016. The increase in write-offs was the result of an increase in overall revenue and uninsured patients in fiscal year 2016. The System does not maintain a material allowance for doubtful accounts from third-party payors, nor did it have significant write-offs from third-party payors. Part III, Line 8 - Medicare Shortfall. In order to assist the organization in determining which health needs should be addressed, THFW categorized the community needs in alignment with the national objectives of Healthy People 2020 categories. By using a strategic prioritization method to determine the top needs within the community aligned with the ability to address the issues, two areas were chosen and addressed through the 2014-2016 implementation plans. The two priority areas from the 2013 CHNA were Chronic Disease and Awareness, Literacy and Navigation. In 2016, THFW continued to align and coordinate services and interventions with community partners for a collective impact to meet the two priority areas defined. Below are some ways in which the priority areas were addressed by THFW.</p> <p>1. Chronic Disease 1a. Community Health Improvement strategies included implementing new evidence-based and maintaining existing chronic disease programs provided at the hospital with a focus on self-management programs. Active partnerships and sponsorships aligned with the strategic efforts to address chronic diseases remained a top priority. 1b. The Chronic Disease Self-Management Program (CDSMP) is a program offered by Texas Health Resources and local community partners with the goal of enabling individuals to build the self-confidence and motivation they need to manage the challenges of living with a chronic health condition. Participants are adults experiencing chronic health conditions such as hypertension, arthritis, heart disease, stroke, lung disease and diabetes. The program provides information and teaches practical skills on managing chronic health problems through the use of lay leaders. In 2016, 40 registrants participated in a six-session course co-served by THFW. 1c. THFW's Wellness for Life Mobile Health visited over 400 locations in Tarrant, Wise, Parker, Hood, Johnson, Erath, Navarro, Somervell and Ellis counties providing mammograms, comprehensive Well Woman examinations and colon cancer screenings targeting low-income, uninsured, culturally or geographically isolated communities. Other services included diagnostic services following abnormal mammogram, history and physical examinations by a Family Nurse Practitioner, biometric measures and glucose, Hemoglobin A1C and cholesterol testing. The scope of services addresses the need for prevention and early detection of cancer, heart disease and diabetes and risk factors such as tobacco abuse, obesity and lack of a primary care provider. 2.
