Business Development Program-The Business Development Program is used as a reliable resource for investors, building owners and tenants serving as a clearinghouse for information, including internally generated data such as the Downtown Office Story, development maps, and independent research. The program underwent a strategic planning process with its stakeholders during 2014, identifying four key initiatives. 1) a plan for downtown that creates the most attractive street level possible, 2) connecting nodes or neighborhoods of high activity in a comfortable and convenient manner, 3) improving technology as an amenity for people who live, work, and enjoy downtown, and 4) expanding the presence of higher education institutions in downtown. The goal of the program is to recruit and retain office tenants and encourage quality development to bring employers and jobs to downtown.

4b (Code:) (Expenses \$ 25,000 including grants of \$ 25,000) (Revenue \$)

Transportation Access: Transportation Program Advocacy is one of the four key initiatives called out in the organization's strategic framework. Central Houston advocates on behalf of downtown stakeholders to maintain priority access, effective commuting methods, and work with the City of Houston and other agencies including TxDOT, METRO, and H-GAC to coordinate transportation projects that impact downtown. Contribution includes funding for a part-time staff director, research, and preparation of the Downtown Commute Survey.

4c (Code:) (Expenses \$ 30,000 including grants of \$ 30,000) (Revenue \$)

Living Central Education Initiative - The program is one of the four key initiatives called out in the organization's strategic framework. Living Central seeks to highlight the quality K-12 educational choices available to residents of the central city. The program has identified a steering committee made of up parents, relocation professionals, HR representatives of employers, and educators. The goal is to provide a reliable, accessible, and robust source of information regarding the educational choices available and assist parents with navigating the requirements to get to their school of choice. Funding includes consulting expenses to lay the foundation for the program, a part-time coordinator for the program, and development of a web-tool that will be a useful gateway to support parents in connecting to these quality schools so that they can remain living in the central city.
