IN TOTAL, THE SOUTHERN TEXAS PGA FOUNDATION OPERATES MORE THAN 300 GOLF TOURNAMENTS, CLINICS, AND PROGRAMS. IN ADDITION, THE FOUNDATION RUNS A "LITTLE LINKSTERS" PROGRAM DESIGNED FOR AGES 7-12 OF ANY SKILL LEVEL. THIS IS AN INSTRUCTIONALLY BASED PROGRAM TARGETING THE RULES OF GOLF AND ETIQUETTE, AS WELL AS GOLF FUNDAMENTALS. THE PARTICIPANTS ARE ALSO GIVEN THE OPPORTUNITY TO PLAY IN ORGANIZED TOURNAMENTS.
