

Redbird has six major service/program areas. The additional three program areas not listed on Part III are:

Blanket, Toy and School Supplies Drive and Mini-Powwow, held annually the first Saturday of December 2016 marked our 21st year.

Pinon Project - the restoration of piñon trees to the Angeles National Forest, which due to the drought, has been an inactive program for a number of years. We anticipate a seed harvest in autumn 2017.

Highway 2 - the journey and the destination - a multi-artist, multi-media show which engages people in artistic endeavors, and combines works of art with educational programming.
