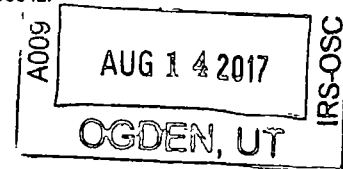

The Midwife Program in Matagalpa, Nicaragua

Expenses \$ 5,094

The Midwife Program provides on-going training and support to midwives and women's community health workers who have completed Skills to Save Lives Program. Programs are developed based on the needs of women and families in the communities where these midwives live. The project continues to work with forty-five (45) traditional midwives and community health workers from 42 communities in Rio Blanco, Waslala, La Dalia, Matiguas and Rancho Grande in the municipality of Matagalpa, Nicaragua. Intense monitoring and support of health workers is an integral part of the program. Twenty-four (24) health professionals (primarily doctors and nurses from the Ministry of Health) participated in workshops to help them support the midwives/women's health promoters as well as to improve their skills in identifying and addressing the needs of abuse survivors. During 2016, six (6) workshops provided education to midwives/women's health care workers and leaders in the medical community. Forty-eight (48) individuals participated in programs on dental health and cervical cancer prevention and twelve (12) individuals completed the next phase of the Alternatives to Violence program. Health workers completed community assessments which included the number of families in each community, number of pregnant women and if they were high risk, number of women who gave at an institutional setting, how many women used contraceptives, had or needed a pap and other factors. These health workers use the education they received and the results of their community assessments to plan programs in their home communities. During the past year, midwives/health promoters provided 2,061 people with education about dental health, alternatives to violence, cancer prevention, HIV, early childhood development and cleanliness. Twenty-four (24) local health care leaders (doctors and nurses) participated in a 2-day program on the identification, support and follow-up of victims of violence. Fifteen (15) abuse survivors identified by health promoters and leaders were provided medical, psychological and legal support during 2016. Health promoters continue to identify persons affected by abuse and the project staff is working to identify creative ways of meeting their needs. The project works not only with the Ministry of Health, but also the Ministry of the Economy (to help the abused women and the unpaid health workers find a "cottage" industry to support themselves), ProNica, Quakers Managua (which helps to support the Alternative to Violence Program), the local Casas Maternas, and other local organizations.
