 COMMUNITY MOMENTUM - THE PROGRAM ENABLED FIRST 5 FUNDAMENTALS (F5F) TO EFFECTIVELY LEAD PROJECT CHILD SUCCESS (PCS) - PIERCE COUNTY'S EARLY LEARNING MOVEMENT. OVER 90 ORGANIZATIONS AND INDIVIDUALS IN PIERCE COUNTY HAVE COME TOGETHER TO ACHIEVE THE VISION THAT ALL CHILDREN THRIVE IN NURTURING RELATIONSHIPS AND ENVIRONMENTS. F5F IS THE NON-PROFIT ORGANIZATION THAT PROVIDES STAFFING, LEADERSHIP, COMMUNICATION, AND DATA SUPPORT TO PCS. WORK INCLUDES LEADING NETWORKING OPPORTUNITIES FOR COMMUNITY PARTNERS, PLANNING SHARED PROFESSIONAL DEVELOPMENT EVENTS AND LEARNING OPPORTUNITIES, ORGANIZING RESEARCH AND DATA PROJECTS, AND FACILITATING ADVOCACY AND POLICY DEVELOPMENT.

THE GOAL WAS TO BETTER UNDERSTAND THE CURRENT SYSTEM OF SERVICES FOR CHILDREN AGES FROM BIRTH TO THREE YEARS OLD IN PIERCE COUNTY. TWENTY-SEVEN INFORMATIONAL INTERVIEWS WERE AUDIO RECORDED, TRANSCRIBED, CODED, AND ANALYZED TO GAIN A DEEPER UNDERSTANDING OF WORK CURRENTLY BEING CONDUCTED AS WELL AS TO IDENTIFY GAPS. F5F THEN CONVENED STAKEHOLDERS TO DISCUSS THE DATA, ORGANIZATIONS PLANNED ACTIVITIES AND STEPS THEY COULD TAKE TO ADDRESS IDENTIFIED GAPS. A FINAL REPORT, WHICH INCLUDES A SUMMARY OF FINDINGS, IS AVAILABLE AT PROJECTCHILDSUCCESS.ORG.

 READY SET GO! 5210 INITIATIVE - THE PROGRAM IS A COMMUNITY INITIATIVE THAT PROMOTES HEALTHY EATING AND ACTIVE LIVING. THE CORE COMPONENTS INCLUDE 5 SERVINGS OF FRUITS AND VEGETABLE EACH DAY, 2 OR LESS HOURS OF RECREATIONAL SCREEN TIME, 1 OR MORE HOURS OF PHYSICAL ACTIVITY, AND 0 SUGARY DRINKS. THIS PROJECT AIMED TO PROMOTE THE 5210 AMONG PROJECT CHILD SUCCESS PARTNERS AND FAMILIES THROUGH THE CREATION OF THE 2016 HEALTHY INCENTIVES CHALLENGE. THE CHALLENGE AIMED TO MAKE HEALTHY LIVING AN EASY CHOICE BY ADDRESSING SMALL ENVIRONMENTAL CHANGES THAT HAVE BIG IMPACT: CHILD CARE CENTERS, FAMILY CHILD CARE, PRESCHOOLS, WORKPLACES, SCHOOLS, NON-PROFITS, AND OTHER ORGANIZATIONS APPLIED FOR ITEMS RANGING BETWEEN \$100-\$500 THAT WOULD MAKE THEIR ENVIRONMENTS HEALTHIER AND ADDRESS THE 5210 COMPONENTS. IN TOTAL 29 ORGANIZATIONS RECEIVED A VARIETY OF ITEMS SUCH AS WATER BOTTLES, BIKE HELMETS, DIRT FOR GARDEN BEDS, AND CHILDREN RAIN BOOTS. TOGETHER, THE AWARDEES SERVE OVER 15,500 CHILDREN IN PIERCE COUNTY.

 PLAYING UP STEAM - EXPERTS IN EDUCATION ALL AGREE THERE IS A NATIONAL IMPERATIVE TO GRADUATE STUDENTS WITH A THOROUGH UNDERSTANDING OF SCIENCE, TECHNOLOGY, ENGINEERING, ARTS AND MATH (STEAM). HOWEVER, MUCH OF THE SOLUTIONS HAVE BEEN FOCUSED ON K-12 EDUCATION, NOT TAKING INTO ACCOUNT OUR EARLIEST LEARNERS. LOCAL DATA SHOWS THAT KIDS IN PIERCE COUNTY ARE ALREADY BEHIND WHEN THEY ENTER KINDERGARTEN. THE PLAYING UP STEAM PROJECT ADDRESSED THIS NEED BY WORKING WITH CHILD CARE PROVIDERS AND FAMILIES TO INCREASE USE OF STEAM ACTIVITIES WITH CHILDREN AGE BIRTH TO FIVE. THE PROGRAM INCLUDED ONE-ON-ONE TRAINING/COACHING WITH CHILD CARE PROVIDERS TO DISCUSS CURRICULUM AND CLASSROOM DESIGN, HOSTING FAMILY PLAY EVENTS TO DEMONSTRATE LOW/NO COST ACTIVITIES PARENTS CAN DO WITH CHILDREN AND SHARED PROFESSIONAL DEVELOPMENT TRAININGS FOR TEACHERS. THE PROGRAM SERVED NINE CHILD CARE SITES AND AN ESTIMATED 150 CHILDREN BUILDING RESILIENCY THROUGH PARENT CAFES - THE GOAL OF THIS PROGRAM WAS TO STRENGTHEN RESILIENCY OF FAMILIES OF YOUNG CHILDREN BY INCREASING KNOWLEDGE AND UNDERSTANDING OF ADVERSE CHILDHOOD EXPERIENCES (ACES) AND THE PROTECTIVE FACTORS. THE TARGET AUDIENCE WAS PARENTS, EARLY LEARNING PROVIDERS, AND SCHOOL STAFF. SCIENCE SHOWS ACES BECOME EMBEDDED INTO A CHILD'S BIOLOGY AND AFFECTS BRAIN DEVELOPMENT, LONG-TERM HEALTH OUTCOMES, AND BEHAVIOR. PARENTS HAVE AN IMPORTANT ROLE AS THEIR CHILD'S FIRST TEACHER, AND SUPPORTING THEIR CAPACITY IS CRUCIAL TO THE SUCCESS OF THEIR CHILDREN'S SCHOOL READINESS THROUGH A PARENT CARE MODEL. FAMILIES ENGAGED IN A SERIES OF MEANINGFUL CONVERSATIONS ABOUT HOW TO BUILD PROTECTIVE FACTORS THAT MITIGATE THE IMPACTS OF TRAUMA. IN ADDITION TO PARENT CAFES, F5F HOSTED AN ACES AND PROTECTIVE FACTORS TRAINING AT PIERCE COUNTY'S ANNUAL WAKIDS CONVENING. THIS EVENT WAS FOR ALL 15 SCHOOL DISTRICTS IN PIERCE COUNTY AND INCLUDED TOOLS TO IMPLEMENT TRAUMA INFORMED TEACHING PRACTICES.
