These workshops included "Infinite Possibilities", Education Day, Health Day, Healthy Relationships Day, and Career Day. Engaged in a 1 day meeting in February in preparation for the student field trip. Executed a spring break summit and a field trip to Orlando, Florida for 103 students. Executed three days of training in Orlando, including leadership, relationship building; dressing for success, communications skills and afternoon fun in the parks. Executed a graduation ceremony for the students. Hosted alumni meetings. Hosted field trip to Dallas, TX in May, 2016 for 53 alumni students. Engaged 45 Pre-K to 6th grade students in educational and personal development activities. Hosted field trip to Memphis in June for 44 students. Hosted field trip to Choctaw, MS in June for 44 students and one of their parents or guardian. Conducted 5 workshops in "Infinite Possibilities" for community adults and youth.

Part III, Line 1 Our mission is to be a change agent in the transformation of poor and low income communities from a perceived place of poverty, low skills, and despair to a place of prosperity, abundant skills, and hope. The Dollars For Your Thoughts program engaged 90 Sunflower County middle and high school students in 5 weekly training sessions for 5 hours per week and in dialogue and conversation about their present circumstances and their outlook for the future. These dialogues included discussions about health, nutrition, education, race, social interactions, and healthy relationships. The conversations entailed demonstrating how our thoughts and feelings about our present circumstances and our outlook on life determines what our future will look like. The training classes also help students to align their unique strengths, talents, gifts, and greatest passions with a clear vision for their future. The intention of this project is to inspire youth to take purposeful action in the present so that they can create a life of great fulfillment for the future. One of our goals is for the students completing the program to have a positive impact on their peers and on the Mississippi Delta. We also engaged 400 students from the 2012, 2013, 2014, and 2015 completion groups in alumni meetings and community service projects, as well as, continuing dialogue. Additionally, we provided a summer program to 1st through 6th grade, where we teach reading, health, and science for 4 days a week for 4 weeks. This year we provided nutritious food from the food pantry to approximately 280 families per month. We provided numerous field trips to expose the students to life outside the Mississippi Delta.
