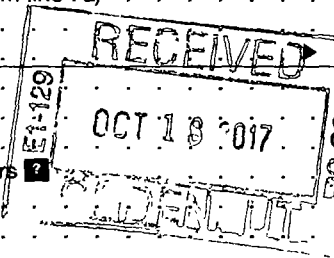

1. Our 2016 work was located primarily in Ghana where we worked with the village of Otoase to increase access to drinkable water by 150% b
adding and increasing the size of water tanks.

2. We provided funds for Days for Girls Ghana to provide feminine hygiene products and education to poor girls in villages to keep them
in school and end the cycle of early pregnancy and poverty.

3. We work with the Catholic Orthopedic Training Center to provide access to donated texts and train their faculty on technology education.

This work is done in conjunction with Eastern Washington University where Dr. Jackson and Dr. Mackelprang teach.
