MLR worked with numerous landowners in 2016 to permanently protect their private lands for continued agricultural production, open space, and natural habitat. Fourteen of these landowners donated or sold conservation easements to MLR that protected over 32,259 acres, including additional acreage in the Greater Yellowstone and Northern Continental Divide ecosystems bordering Yellowstone and Glacier national parks. Nearly 43 miles of river/stream frontage on some of Montana's blue ribbon trout fisheries were protected in perpetuity. Over 85% of the easements completed in 2015 were adjacent to or within 5 miles of properties already protected by conservation easements. MLR is near that 1,000,000 acres of land protected with 990,323 acres of agricultural/recreational lands in Montana currently under easement. That acreage includes 162,023 acres of crop/hay/pasture lands; 828,023 acres of forest/range lands; 1,675 miles of river/stream frontage; 546,743 acres of prime elk habitat; and 10,070 acres of wetlands.

MLR stewardship staff (consisting of the Lands Manager, a full-time Land Steward, and 14 seasonal Land Stewards) monitors each and every property on which MLR holds a conservation easement. This monitoring includes a visit to the subject property and discussions with the landowners and managers. The stewardship staff also works with existing easement holders to supply natural resource information and contacts for the landowner to improve their land holdings for conservation purposes. Stewardship staff also works with legal counsel in regard to any potential issues that arise regarding interpretation or enforcement of conservation easements held by MLR. For a list of stewardship and monitoring related expenditures, please see Schedule O.

MLR granted \$153,450 to the Montana Land Reliance Foundation, Inc., to be invested into the Land Protection Fund to cover stewardship and monitoring expenditures.

MLR staff travel across the state of Montana conducting meetings with potential clients, county planning boards, county commissioners, various agricultural groups/organizations, and other community groups to provide answers to their questions and to conduct general educational activities focused on the benefits of land conservation and conservation easements. For these outreach activities, MLR publishes various educational brochures and an annual report to provide information and enhance the transparency of its public interest activities. Additionally, staff participate with numerous conservation groups to educate the general public about the land trust community's conservation efforts. PART II, Line 3 (conservation easement modifications): Of the total 838 conservation easements held by MLR at the end of 2016, six (6) easement documents were modified (less than 1%). The purposes of the one (1) correction, one (1) Ratification and Amendment of Deed of Conservation Easement, and four (4) Restatement of Deed of Conservation Easement and Grant Deed of Conservation Easement on Additional Lands documents were to correct errors or omissions that occurred when an easement was drafted, to further restrict the property subject to the easement (removal of permitted rights to build and transfer portions of the property), to add additional lands to the easement property, and to eliminate ambiguities in easement terms that could have led to enforcement challenges by updating outdated conservation easement language. All six of the easement modifications also secured the landowners' ratification of the terms and conditions of the conservation values and purposes of the original easements. As an accredited land trust, MLR followed rigorous conservation easement amendment policies to ensure perpetual protection of the conservation values and to avoid conferral of prohibited private benefit and inurement, all in accordance with national standards and practices as recommended by the Land Trust Alliance.

Part XIII Supplemental Information *(continued)***Correction:**

1) Reints Property - This easement was originally recorded on August 26, 2016, as Document No. 168516 Records, in the public records of Madison County, Montana. This easement protects 118 acres that lie across the Madison River from the town of Ennis, Montana, and protects river frontage and a portion of the famed O'Dell Spring Creek. The easement was corrected by that certain Correction of Deed of Conservation Easement recorded on November 10, 2016, as Document No. 169690 Records, public records of Madison County. The correction was necessary to record Exhibit E (which was erroneously not attached to the original recorded document) in the public records.

Amendment:

2) Hutchins Property -- This 92-acre property was protected by a Deed of Conservation Easement originally recorded on December 10, 2015, as Document No. 301635, Book 1 Recordings, Page 84121, records of Sanders County, Montana. In that original easement document, the landowner retained the right to construct two new residential dwelling units and to transfer the property in two parcels. The Ratification and Amendment of Deed of Conservation Easement, recorded on December 27, 2016, as Document No. 305031, Book 1 Recordings, Page 86932, records of Sanders County, Montana, removed the right to construct one of the residential dwelling units and removed the transfer right (the property now can transfer in one parcel only).

Restatements:

3) Parks Property -- This property in the Yellowstone River Valley was first protected by a Deed of Conservation Easement recorded on December 24, 2002, as Document No. 3207417, records of Yellowstone County, Montana. Since that time, the landowner purchased an adjacent 33-acre parcel that connected his northern boundary to the Yellowstone River, and was bordered on the east by a public access site and camping area administered by the State of Montana. The easement was restated to incorporate the 33 acres into the existing 80 acres under protection -- the 113 acres must transfer as one parcel only, and no structures are permitted outside of an established building envelope on the original 80-acre parcel. The removal of any construction rights on the 33-acre parcel was key to protection of this area for the public using the adjacent camping area.

The Montana Land Reliance Foundation, Inc. was established in 2010 to provide services to The Montana Land Reliance (MLR) to provide financial assistance to MLR and to hold assets in support of MLR. Two members of MLR's Board of Directors serve on the Board of the Montana Land Reliance Foundation to provide oversight of the use of funds provided to the Foundation by MLR. There are three other members of the Foundation's Board that are not members of the MLR Board and provide further oversight of the funds. MLR monies granted to the Foundation are invested to provide income that is then granted to MLR to assist in the completion of land projects, to assist with the financial burden of monitoring existing conservation easements, to assist MLR with costs associated with its education and outreach program to landowners, professionals, and other conservation organizations, and to assist MLR with its general operating expenses. In 2016, MLR granted \$153,450 to be invested into the Land Protection Fund (income from which is used to assist MLR with conservation easement project costs and monitoring/stewardship costs).

There are two current members of MLR's Board of Directors who serve on the Board of Directors of the Montana Land Reliance Foundation -- Carol Bibler and Jerry Townsend. These two individuals provide oversight of the funds that MLR invests in the Foundation to further its conservation efforts across the state of Montana. Three members of the Foundation's Board of Directors are not members of MLR's Board of Directors and provide additional oversight of the investment funds.

Through an Intercompany Services Agreement, MLR provides accounting/bookkeeping and administrative support to the Montana Land Reliance Foundation. In 2016 these services amounted to \$36,000.

In 2016, the Montana Land Reliance Foundation's Board of Directors approved a grant request from MLR in the amount of \$482,908 to cover MLR's costs related the monitoring/enforcement of the 838 conservation easements currently held by the organization and costs related to education and outreach activities to the general public and other organizations and government agencies.

MLR staff provides, through an Intercompany Services Agreement, investment and tracking support to the Ruby Habitat Foundation. The resident of MLR's Board of Directors and two of the Managing Directors of MLR serve on the Board of Directors of the Ruby Habitat Foundation to provide oversight.

4) Circle 3 Ranch -- This 1,855-acre property lies just north of the town of Dillon, Montana. The original 1,323-acre ranch was protected by a Deed of Conservation Easement recorded on December 18, 2013, as Document No 280666, Book 379, Page 1348-1376, records of Beaverhead County, Montana. The Restatement of Deed of Conservation Easement and Grant Deed of Conservation Easement on Additional Lands protected an additional 531 acres that the landowner purchased since the original donation in 2013. These two new parcels border the existing easement property to the north and to the south and protect an additional 4.5 miles of river and stream frontage. The property in total can now transfer only in two parcels (one of which will be strictly for open space and agricultural purposes, there are no residential building rights on one of these two parcels).

5) Switchback Ranch -- This 16,728-acre ranch is located in the Stillwater River Valley near Red Lodge, Montana. The original 15,763 acres was protected via a Restatement of Deeds of Conservation Easement and Grant Deed of Conservation Easement on Additional Lands recorded on December 24, 2014, as Document No 360612 Easements, records of Stillwater County, Montana, and recorded on December 26, 2014, as Instrument File #360132, and rerecorded on December 30, 2014, as Instrument File #360146, records of Carbon County, Montana. The landowner subsequently purchased 960 acres that was adjacent to the main ranch property. The Grant Deed of Conservation Easement on Additional Lands and Ratification of Previous Restated Deed of Conservation Easement, recorded on December 27, 2016, as Instrument File #368607, records of Carbon County, Montana, and recorded on December 27, 2016, as Document #367457 Easements, records of Stillwater County, Montana. The 2016 easement incorporated the newly purchased 960-acre parcel into the main ranch parcel of the original restated easement.

6) Gilleon Property -- This 1,995 acre property lies just northeast of the town of Cascade, Montana. The Restatement of Deeds of Conservation Easement and Grant Deed of Conservation Easement on Additional Lands consolidated four previously recorded Deeds of Conservation Easement that were granted on the property: 1) Deed of Conservation Easement recorded on December 17, 1996, as Reel 288, Document 1335; 2) Deed of Conservation Easement recorded on December 21, 2001, as Document #R0019843; 3) Deed of Conservation Easement recorded on December 24, 2007, as Document #R0163872 ES; and 4) Deed of Conservation Easement recorded on December 21, 2001, as Document #R0019844, all in the records of Cascade County, Montana. The current landowner now owns all four easement properties and has also purchased an additional 119-acre property that is adjacent to the existing properties. The restatement and grant permanently eliminated the landowners right to construct two residences, reduced the number of tracts that could be separately transferred from 11 to 3, added the 119 acres into the protected block, and reaffirmed, restated, and strengthened the prior conservation easements.

By a resolution of the Board of Directors, MLR values all conservation easements held at a nominal amount of \$1 due to the fact that said easements cannot be sold, transferred, or borrowed against. Expenses incurred in "bargain" purchases of easements and other in-house expenses related to completion of conservation easement are expensed out in the year of the purchase and/or donation. The following is the text of the footnote used in MLR's annual audited financial statements. "MLR has acquired conservation easements from various contributors. Conservation easements represent rights to restrict use of certain properties. By accepting the easement contribution, MLR commits to protecting the easement restrictions in perpetuity. The easements have no market value in the hands of MLR. MLR can assign the easements only to another qualified conservation organization. The Ruby Habitat Foundation is a 501(c)(3) (public charity status - 509(a)(3)) support organizations of MLR that is dedicated to preserving and enhancing the natural resources, and social and economic makeup of the Ruby Valley and southwest Montana.

PART II, Line 2:

The Montana Land Reliance Foundation is a 501(c)(3) (public charity status - 509(a)(3)) the purpose of which is to provide services and financial assistance to MLR, and to hold assets in support of the programs administered by MLR.

PART V, Line 1b:

MLR granted \$153,450 to the Montana Land Reliance Foundation to be invested to generate income for MLR's operations and stewardship and monitoring activities related to its conservation work across the state of Montana.

PART V, Line 1c:

MLR received a grant from the Montana Land Reliance Foundation in the amount of 482,908 to cover costs related to its education and outreach activities, and to the stewardship, monitoring, and enforcement of the 838 conservation easements MLR currently holds.

PART V, Line 1i:

MLR received \$36,000 from the Montana Land Reliance Foundation per the Intercorporate Services Agreement executed by the two entities for accounting/administrative services. MLR also received \$6,000 from the Ruby Habitat Foundation, another support organization to MLR, per the Intercorporate Services Agreement those two entities executed for investment/accounting services.

PART V, Line 1g:

The Montana Land Reliance Foundation reimbursed MLR for its portion of directors' liability insurance (\$1,214), filing of its annual report with the State of Montana (\$20), and the Foundation Director's costs for lodging/meals during MLR's Annual Meeting (\$556). The total reimbursement was \$1,790.

The Ruby Habitat Foundation reimbursed MLR for its portion of directors' liability insurance (\$1,214), Directors' costs for lodging/meals MLR's Annual Meeting (\$832), and for maps MLR staff generated for the Ranch (\$55). The total reimbursement was \$2,101
