

OUR CORE VALUES - Respect, Compassion, Justice, Excellence, and StewardshipFebruary is Heart Health Month and here at St. Joes we continue to show our commitment to community health and wellness. NATIONAL WEAR RED DAYProvidence St. Joseph Medical Center encouraged caregivers to wear red on National Wear Red Day, Friday February 5th, 2016 in an effort to raise awareness about women's health. 80% of cardiac events in women could be prevented if women made the right choices for their hearts involving diet, exercise and abstinence from smoking. During February St. Joes offered the following screenings: LIPID PROFILE Community members received a Lipid Profile at no charge. CARDIAC HEALTH PROFILECommunity members were also offered a Cardiac Health Profile. This profile included: Complete Metabolic Panel, Complete Blood Count & Thyroid Stimulating Hormone lab tests. BASELINE EKGAll EKGs were read by a cardiologist from the International Heart Institute in Missoula. CPR CLASSESFREE Heart Saver CPR classes were offered in February. In honor of Heart Health Month, Providence St. Joseph Medical Center held courses in February and conducted the classroom, video-based course to teach adult CPR and AED use, as well as how to relieve choking in an adult. This course was for anyone with limited or no medical training who needed a course completion card in CPR and AED use to meet job requirements or for general preparedness. REACH AND READ PROGRAM Providence St. Joseph Medical Center caregivers introduced the Reach Out and Read Program to St. Joe's Reach Out and Read is a nonprofit organization that gives young children a foundation for success by incorporating books into pediatric care and encouraging families to read aloud together. The Reach Out and Read evidence-based program builds on the unique relationship between parents and medical providers to develop critical early reading skills in children, beginning in infancy. As recommended by the American Academy of Pediatrics, Reach Out and Read incorporates early literacy into pediatric practice, equipping parents with tools and knowledge to ensure that their children are prepared to learn when they start school. Reach Out and Read serves nearly 4.5 million children and their families annually. Reach Out and Read families read together more often, and their children enter kindergarten with larger vocabularies and stronger language skills. During the preschool years, children served by Reach Out and Read score three to six months ahead of their non-Reach Out and Read peers on vocabulary tests. These early foundational language skills help start children on a path of success when they enter school. A new physician joined the surgical staff at Providence St. Joseph Medical Center. The physician joined the growing group of surgeons dedicated to serving Lake County and the Mission Valley. As the only full-time general surgeon in our community, the physician offers nearly a decade of experience in a range of procedures, including colonoscopies, hernia repair and gall bladder and appendix surgeries. He joins our team already providing surgical expertise in orthopedics and OB-GYN. 28 caregivers from Providence St. Joseph Medical Center and the Montana Cancer Center participated in the 8th annual Women 4 Wellness event. Caregivers representing St. Joseph's OB-GYN and family practice departments were on hand supplying information. A pediatrician was on hand, plus caregivers supplying information about immunizations and the Lake Shore Pharmacy. The true heroes were the caregivers who drew blood for the free Comprehensive Metabolic Panels, Complete Blood Count and Thyroid Stimulating Hormone tests. Over 300 tests were performed. Montana Governor Steve Bullock visited Providence St. Joseph Medical Center in September. The stop was part of the governor's "Innovate & Educate" tour which highlights new education initiatives. The governor was interested in learning about the Polson High School - Providence St. Joseph Medical Center Student Internship Program. Governor Bullock spent about 20 minutes interacting with program administrators and former students and then another 25 minutes visiting various hospital departments before concluding his tour. The Montana Superintendent of Public Instruction visited Providence St. Joseph Medical Center in September to receive first-hand knowledge of the St. Joseph and Polson High School Student Internship Program. She met with past and current students, school administrators and St. Joseph program directors to learn more about the program. She was interested in finding out what makes the program successful and what challenges were faced. Providence St. Joseph Medical Center celebrated Breast Cancer Awareness month with three Pinkalicious Ladies Night Out events. Community members were offered free mammograms. OB/GYNs were available to answer questions and offer breast exams. Through the Frontier Medicine Better Health Partnership (FMBHP) Medicare innovation grant, Providence St. Joseph Medical Center was able to partner with the Montana Office of Rural Health (MORH) and National Rural Health Resource Center (NRHRC) to facilitate development and distribution of surveys which were mailed out to the residents in Providence St. Joseph Medical Center's service area in June 2014. Additional paper surveys were available at the county library, county public health office and the hospital lobby. An online version was also distributed via email campaign and Providence St. Joseph Medical Center's Facebook page to capture the broadest audience possible. Finally, five focus group sessions were held at a variety of locations such as a local senior citizen center, public library and at a local, tribal owned power company's meeting hall. The Steering Committee and the Mission and Values Sub-Committee of the Providence St. Joseph Medical Center Board and the administrative team met as one group once and individually on numerous occasions for results review and discussion of the data. From the survey data, community input, recommendations from the steering committee and Mission and Values sub-committee, the Providence St. Joseph administrative team distilled four key items to focus community benefit efforts over the next three years. This was then developed into a community health implementation plan.</p>

Joint ventures include research collaborations (cardiac, neuroscience and oncology) with the University of Montana, affiliations with long term care facilities, and the Indian Health services clinic, among others. Providence St Joseph Medical Center conducts local assessments to make sure the needs of the community are met. The community ministry board of directors oversees and approves the annual community benefit plan that addresses the health care disparities within the community. The community benefit plan is developed and reviewed annually to ensure that the proposed outcomes are being met. This plan is implemented in concert with others in the community to increase the accountability that we share with them to improve the health of our community and to not duplicate services. Access to mental health services is one of the top priorities of the community and St Joseph Hospital coordinates the Lake County crisis committee to address both the short and long term solutions. By collaborating with community groups, a new mental health crisis facility is being built, access to tele-psychiatry services in primary care as well as direct services from an LCSW and Advanced practice RN are now in place. Additional efforts are underway to minimize the impact of mothers delivering babies while under the influence of drugs and alcohol through the Best Beginning committee that St Joseph staff participate on.</p>

Providence has a single fiduciary Board, with responsibility for financial oversight associated with fulfillment of the Providence Mission, developing system policies, protecting the assets entrusted to the organization and overseeing the strategic and operational affairs of Providence's legal entities. Providence also maintains a network of community ministry boards with responsibility for quality of care oversight, community relations, advocacy and community needs assessments. Providence has a consistent compensation philosophy for all of its officers, including our senior executives. Salaries for senior executives are reviewed by the Providence St. Joseph Health Committee and approved by the full Board of Directors, none of whom is a Providence employee. The Board retains an independent consultant each year to review salaries of those in the most significant leadership roles in the organization. Part of the consultant's role is to review an extensive array of compensation surveys of large, not-for-profit health care systems in the United States. Providence is one of the larger health systems in the country, and as such, the Board benchmarks executive compensation against other large, not-for-profit health systems whose revenue is similar to that of Providence. Additionally, Providence's labor market continues to spread across health care and into general industry. Because of this, Providence also takes into consideration general industry for-profit market data, where applicable. Base salaries for Providence executives are generally targeted to the median level of the market, as identified by the independent consultant and reviewed with the Executive Compensation Committee. Each year, the Board Chair conducts a formal performance evaluation of the President/CEO that considers input from the other directors and senior leaders reporting to the President. The evaluation is discussed with the Executive Compensation Committee and then a recommendation is made by the committee to the full Board. The Board Chair and the Chair of the Executive Compensation Committee also meet with an independent consultant to develop a salary recommendation, which is reviewed and approved first by the committee and then by the Board of Directors. Additionally, the President/CEO utilizes the market information provided by the consultant along with formal performance evaluations, to determine salary recommendations for other senior executives. This process includes a rigorous analysis of those recommendations with the Executive C</p>
