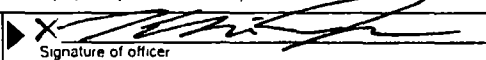

DURING THE SHORT CALENDAR YEAR, HABITAT FOR HUMANITY SOLD A PRIOR PARTNER FAMILY'S HOUSE RECLAIMED THROUGH THE AFFILIATES FORECLOSURE PROCESS THAT WAS DEEMED UNSUITABLE FOR REUSE AS A HABITAT FOR HUMANITY HOUSE AND ANY CORRESPONDING NEW PARTNER FAMILY. SUBSTANTIAL REPAIR WAS REQUIRED AND PERFORMED BY THE ORGANIZATION PRIOR TO SALE. THE FUNDS RECEIVED FROM THE SALE WERE USED TO HELP FUND THE CURRENT CONSTRUCTION OF HABITAT'S 50TH AND 51ST HOMES STILL IN PROGRESS AT DECEMBER 31, 2016 AND FOR FUTURE LAND PURCHASES.
