The Blackfoot Challenge coordinates community-based programs to protect working land, conserve water and promote water use efficiency, educate all ages, increase fire safety and restore our forests, promote the values of community-based conservation, improve cross-boundary vegetation stewardship, and reduce conflicts between predators and people. Our success is structured by a strict process that leads with community values, invites participation from all watershed stakeholders, coordinates the conversations and partnerships, and supports these partnerships with good science.
