

The Board Members are all volunteers and receive no compensation. The Treasurer is a volunteer who has no voting rights and has no authority over the members or decisions made by the members. Meetings are held quarterly. The annual financial statements are inspected by an independent auditor and a certificate issued. The statements are presented at the Annual Meeting of members of Holy Spirit Episcopal Parish.
