Montana Conservation Voters, Inc.'s primary exempt purpose is to educate and activate voters to be vital and effective participants in Montana's democratic process, to protect air and water quality, public health, fish and wildlife and open space. MCV informs the public about the votes and actions of local, state and federal elected officials pertaining to conservation and environmental issues, and encourages their involvement in government.

Conservation Policy Campaign: MCV's 2016 Conservation Policy Campaign was dedicated to working with the Bullock Administration on a pro-active Energy Blueprint and Public Lands Agenda which were rolled out in June 2016. Additionally, MCV previewed a pro-active legislative strategy for the 2017 legislature while also preparing against any rollbacks of key environmental laws. Specific areas of work in 2016 included:

- 1) Engaging the Bullock Administration to create a pro-active energy strategy in the absence of the Clean Power Plan. In June 2016, Bullock presented his Energy Blueprint that included, among other things, goals on generating more renewable energy in Montana, improving energy efficiency and establishing a Property Assessed Clean Energy (PACE) program.
- 2) Engaging the Bullock Administration to create a pro-active Public Lands Agenda which he announced in June 2016. The Agenda included creation of a public access specialist within the Department of Natural Resources & Conservation, a new Office of Outdoor Recreation within the Office of the Governor, and restoring the Habitat Montana so it could acquire land to increase access to public lands, streams, and rivers.
- 3) Working with the newly elected 2017 Montana State Legislature to educate them about pending proposals to advance clean, renewable energy and energy efficiency,

public lands protection, as well as clean water laws and measures to ensure broad-based citizen participation, while opposing roll backs.

4) Opposing proposals to transfer federal lands to the state as well as the dedication of any state funds to study this.

5) Continuing work during the 2015-167 interim legislative period by testifying before the Interim Energy and Telecommunications Interim Committee regarding net metering policies

6) Coordination of meetings of the Conservation Working Group, a coalition of groups organized to advocate for strong environmental policies post-election and pre-session to establish legislative policy priorities.; and

7) Work to issue an issues survey poll done biannually by MCVEF on issues, not candidates or elected officials. The polling, done with the assistance of the Conservation Working Group, helped drive messaging for policy work and preparation for lobbying the 2017 legislature.

8) Recruiting and securing appointments of conservation and environmental group leaders to openings on relevant local and statewide boards and commissions.

Accomplishments included preparing positive, pro-active legislation in anticipation of the 2017 legislature including establishing a Montana PACE program, a Public Lands Day, and a proposal to reduce greenhouse gas emissions.. Additional legislative preparation included defensive efforts to defeat legislation that would have rolled back net metering laws in Montana, eliminated the Board of Environmental Review, increased taxes on electric vehicles and alternative fuels, and prevented public input on renewing the lease for a proposed new coal mine in southeastern Montana. Preparing for these accomplishments were achieved with the support of the Conservation Working Group, comprised of 13 allied organizations.

As it does each year, MCV released the national League of Conservation Voters' Congressional Scorecard in February 2016 with a press release and earned media efforts in the statewide and local press. MCV also completed rigorous social media and digital efforts to disseminate the message to a broad audience.

MCV coordinated with chapters and board members to have meetings with legislators and local leaders in Billings, Bozeman, Helena, Missoula, and Tribal leaders in Northern Cheyenne where we discussed legislative priorities for the 2017 Legislature and our environmental policy priorities.

At the federal level, MCV advocated passage of a bipartisan energy bill, funding for EPA's water and wastewater state revolving funds, confirmation of Merrick Garland to the U.S. Supreme Court, as well as range of public lands policies including full funding and permanent reauthorization for the Land and Water Conservation Fund and protection of the Antiquities Act. MCV also continued its work to defend the Clean Air Act and advocate for aggressive carbon reduction goals under the Clean Power Plan. Staff travelled to Washington, DC to lobby Congress (three staff and one MCV Board member), and convened meetings with Senator Tester and his staff as well as staff for Senator Daines and then-Representative Zinke.

In the summer and fall of 2016, MCV chapter leaders and staff prepared non-partisan questionnaires mailed to candidates running for the statewide, legislative, and local offices and invited them to participate at chapter membership meetings. MCV also communicated with members about what was at stake in the 2016 elections and provided

voter information to residents of these communities about the environmental positions of those who responded to questionnaires.

Outreach and Community Organizing: Over the summer of 2016, MCV launched a door to door fundraising canvass. We knocked 9,317 doors, secured 2,411 petition signature of which 1,601 had good emails, and raised \$28,974 renewing 449 members and capturing 385 new members. This campaign was focused on transitioning from dirty coal and moving Montana toward a cleaner more renewable energy future based on rooftop solar, backyard wind and large scale wind farms. The campaign also consisted of regularly onboarding these newly acquired members with an email series that generated an additional 48 comments to Governor

MCV's four chapters, Yellowstone County, Gallatin-Park County, Missoula County and Flathead County each convened membership meetings attended by an individual low of 18 members and a high of 79. Chapter boards meet approximately nine times per year.

A new MCVEF Executive Director was recruited, screened, hired and orientation and training began in late 2015. Throughout 2016 the Executive Director participated in robust staff development and skills training opportunities, including two multi day boot camps for new executive directors from across the national LCV leagues.

The MCVEF Board of Directors and staff also continued a financial literacy program offered by the League of Conservation Voters, "Fun with Financials", which included a "Fiscal Fitness Test" and follow up leadership and staff development program.

Ongoing staff development included participation in monthly League of Conservation Voters Development Director calls, monthly organizing calls and participation at LCV's Executive Director meeting which included a staff development component. MCV staff carried out their professional development plans including training on legal compliance issues, civic engagement, environmental policy and fundraising skills.
