We had to also rent sound equipment, pay for insurance for events. Travel was extensive and the purpose was to participate and conduct inter tribal gatherings and ceremonies at Oak Flat Arizona, Lakota Nations, Navajo communities, San Francisco with Ohlone tribal members. We were successful in building awareness on cultural and spiritual literacy among our youth and allies. We also have established a network with over 3,000 contacts throughout Indian Country.
