MY PLANET EURL Ltd whose registered office is located at 1, Carrefour Longchamp, 75116 Paris, France, VAT NR FR79 491 251 252 represented by its Manager Véronique Jaquet duly authorized for the purposes hereof and acting for the Goodplanet Foundation (hereinafter referred to as "Licensor")

1. Purpose

The Donor, Distributor and Licensor are parties to the tripartite agreement ("The Agreement") entered into on 22 August 2016. 4. Deliveries

In the scope of the present Agreement, the Distributor commits to use the donation to deliver the following performances:

- Coordinate the event with local and international partners
- Research and booking of a New Yorker movie theatre with reception space and all the necessary equipment (DCP reader, 5.1 sound, microphones, posters, etc.)

- Oversee and manage the event's marketing, communication, media coverage and publicity before and after the event, including photographers and videographers on-site. No later than 2 weeks after the event, the Distributor shall provide a PDF compilation of all the media releases covering the event*
- Draft, send, confirm and manage invitations
- Pay and manage the catering (as eco-friendly as possible)
- Pay and manage the event staffing (venue management before and during the event)
- Pay and manage the event's and VIP's security (in accordance with the VIP's protocol)
- Press, guest and VIP's reception management
- Pay the outward and return flight tickets and per diem allowances** of two My Planet team members who will help coordinating the event on-site

* The event management can be delegated to outside service providers

** The per diem include ground transportation, visa fees (if any), 3 daily meals and telephone usage. These per diem exclude accommodation. Both Goodplanet team members will provide the Distributor with expense reports.

5. Approvals

Distributor, Donor and Licensor shall have joint final approval with regard to all marketing materials and invitations. All approvals shall not unreasonably be delayed or withheld. If - after mutual, several and serious attempts - parties will not be able to come to terms on marketing materials and invitations, Licensor's judgment shall prevail.

6. Accountability

Donor and Licensor have the right to check the management of the said fund by the Distributor and to ask for the account and exact resource allocation.

7. Period of Validity

This Agreement takes effect from 22 August 2016 and ends on 22 October 2016.

8. Default and Termination

The Donor, Distributor and Licensor, agree that, in the event of any conflict of terms or of a Force Majeure event that would prevent the successful implementation of the agreement and organization of the aforementioned preview, the amount withdrawn by the Donor shall be reimbursed to the latter.

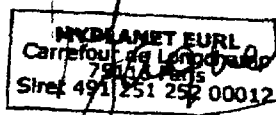
