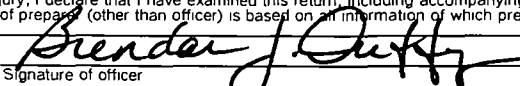

2016 was the initial year for FIRST Global with a focus on the 2017 Grand Challenge to be held in July of 2017. The event planning reached approximately 163 countries in 2017. Each team is allowed a maximum of 7 student competitors to attend the event with an unlimited number of team members allowed to work on the challenge in their home country in preparation for the event. Under the guidance of volunteer mentors, approximately 1,100 high school students planned to attend the event. In preparation for the 2017 FIRST Global Challenge, over 600 volunteers actively mentored participants adopting a total of 84 participating nations. These community-based volunteers range from civic minded high school and college students, to entire university robotics and engineering departments, and provided teams with mechanical, electrical, programming, and strategic advice.
