ArtistYear is a national service organization that enables artists to commit a year of service to their country. The 2016 program funded ArtistYear Fellows to serve as full time teaching artists alongside established arts teachers in two high poverty, federally designated Title I schools in Philadelphia. These ArtistYear Fellows hold undergraduate or graduate degrees in a performing or visual arts field and are highly skilled in their craft. The service year provides the Fellows with an opportunity to use their art to make a difference in the lives of children, schools and communities, while offering training and development that prepares them to be competitive for jobs following their service year. These ArtistYear Fellows served over 800 K-8 Philadelphia students at least three times per week, delivering 6700 hours of arts instruction during the 2016-2017 academic year. The cost per student receiving arts instruction was \$122 annually. ArtistYear believes that the arts are imperative for the development of critical thinking, self discipline, empathy and civic engagement.
