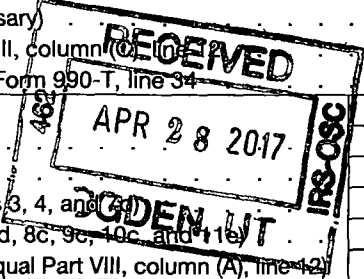

The first of TCVS's activities related to coordination with other service providers so that veterans would have access to programs provided by the public and private sector In Thurston County, there was no central location to obtain housing assistance, to meet with a Veterans Service Officer for assistance in filing a VA claim or to learning more about education and other programs available to veterans Also, the various services for housing, claims assistance, education benefits and assistance in employment were administered by different organizations so that it was difficult for those veterans who may need assistance in more than one area TCVS formed a partnership with the City of Lacey and raised the initial funds for refurbishing the future Veterans Assistance Center, now known as the Lacey Veterans Services Hub The rental space needed re-construction and repair of doorways, repainting of the interior and cleaning to become it ready for veteran usage TCVS volunteers provided the manpower to repaint and repair the veteran's facility and to provide food and material support for the crews of volunteer veterans TCVS also recruited some currently homeless veterans who were willing to volunteer hours of painting and construction work to assist some of their fellow comrades The Veterans Center was refurbished in a period of one month and opened on July 1, 2016

TCVS's third purpose is to inform veterans about the assistance programs that exist Some veterans have been unemployed for some time and in some cases, on the margin of society and therefore, have little or no resources to begin a path toward self-sufficiency A Stand Down event is when an operational unit returns from the field of operations to a base camp for refitting, rest and training Soldiers who have been in the field can clean up, take care of medical problems and rejuvenate themselves The civilian Stand Down is a one-time event where nonprofits and local businesses work together to assist veterans in need of housing, health care, employment assistance, referrals to other organizations for longer time assistance etc TCVS is also an advocate for partnerships between nonprofit organizations and businesses, both types of organizations have specialized abilities to improve lives TCVS performed two functions at the Stand Down First, it distributed a number of information pamphlets about burial benefits which are available to veterans and the location of veteran's cemeteries Second, it distributed gift cards to assist those veterans who did not have sufficient resources to go to job interviews, take care of family needs or heat the campers which were serving as their homes A total of 15 veterans, both at the Stand Down and later at the Veterans HUB were provided gift cards to assist with self-improvement

The final operation during 2016 was related to our third organizational purpose which is reducing barriers to veterans seeking assistance TCVS developed and distributed at the Stand Down a Veterans Needs survey which collected data on the priority that should be given to the following areas \* Benefits, compensation and pensions, \* Employment and re-integration \* Education and training \* Financial Services The survey also captured data on the veteran's knowledge of 14 specific programs The survey indicated that the highest priority items for veterans were disability evaluations, health care, career counseling, transition from the service assistance, job assistance, including transportation, unemployment assistance, legal assistance and college assistance Veterans placed lower priority on financial services and death benefits Veterans were most aware of the employment assistance programs, like the Veterans Outreach Program involving corporate partners, counseling services, morale, welfare and recreational programs They were less aware of Aid and Attendance Benefits, Long term Care, Sexual Trauma, Tax breaks for veterans and veteran organization scholarships
