Traini in the areas of Spanish to English languages, human and social relationships and customs, Hispanic folk music and dance lesssons and the celebration of traditional holidays.

Accomplishments:

As of this time we have exposure throughout the the Hispanic community by virtue of our training center at the Global Mall in Antioch, Tn.. In our cultural center we have currently 18 students learning traditional music and dance from 8 of the 32 states of Mexico. They are for the first time learning how beautiful and rich the spanish heritage truly is and it is very important that they retain this heritage even as they grow up in the American cultural environment. The children learning the Mexican folk dancing are performing dances and the children learning the music are progressing toward a goal of knowing the music from each of the 32 states. Included in learning the traditional music and dances of each stte is the experience of dressing in the traditional styles of each state. Obiously, the cost of these items is very expensive just in terms of materials. All the instructors and staff donate all their time to our Mission and recieve no compensation.
