1) Provide basic seminars teaching participants “the Silva Method”; The Silva Life Systems seminar and The Silva Intuition Training Seminar. The Silva Method is a series of mind exercises and meditation that help you: solve problems, sleep better, remember things, stay awake better, relive headaches, enhance perception, etc. Results may include realization of dreams and achievement of goals.
